In 2022 the Baltimore City Department of Transportation (BCDOT) is shifting the Dockless Vehicle Committee Meetings to be quarterly instead of monthly. During off-months, you can expect an email update in lieu of a meeting- this is the inaugural email! ## Announcements:

- BCDOT releases Dockless Vehicle 6-month program update: Please find the 6-month update report attached to this email and <u>posted online here</u>. This report summarizes the first 6 months of the annual permit, including data, program support, and updates from permit holders.
- Rider Survey to go live in mobile phone apps: BCDOT's annual rider survey is about to launch. The survey solicits feedback specifically from riders in order to inform the annual permit revisions. A clickable link will go live in all of the permit holders mobile phone applications and be accessible from January 17- March 5. After the survey closes, you can expect a results summary and full results in the annual program report. When you see the BCDOT social media post announcement, we ask that you share so that riders can have input into the program!
- MDOT MTA and BCDOT launching transit station survey to solicit feedback about bike and scooter requests and issues. If you ride the Light Rail or Metro, keep an eye out for the scannable QR codes soon linking transit riders to a form for each location.

## Data Updates:

• 2019-2021 Weekly Trips comparison: With 2021 wrapped up, we can see the huge recovery from 2020 trip volumes from July to December. During those 6 months, over 1 million trips were taken on dockless vehicles.




Note that trip numbers labeled are for 2021.

• July – December, 2021 Trips per vehicle per day: Trips per vehicle per day show utilization, from July to December this number stayed in a good range from 1-3, with the drop in utilization linked to weather conditions.
