
Press Release: The City of Baltimore is Now Accepting Permit Applications for its Dockless Vehicle Program. BCDOT will permit up to three (3) dockless vehicle companies this year. One permit has already been awarded to Spin, whose permit was renewed based on compliance and community rankings. Permit applications for the remaining two (2) permits will be accepted through May 20, 2022.

Weekly trips comparison: Charted below are weekly trip counts from dockless e-scooters and e-bikes 2019 to the present.




Renewal Metrics: For the first time, Dockless Vehicle Permit Holders were scored for renewals. Spin received the highest score and was awarded a 1-year renewal.


Permit holders Spin, Link, and Lime were scored in the following categories for renewals:

• Graphed below is a summary of Equity Zone and Deployment District compliance for all 3 permit holders, a metric for permit renewal. This shows how well the companies met requirements to deploy vehicles across all of Baltimore City and to specific equity zones daily. When compliance falls below 85%, two warnings are given before a citation is issued.



• Below is a summary of rider responses to survey questions about brand preferences and usage, a metric for permit renewals representing community rankings.



Survey Updates: There are several surveys underway to improve dockless e-scooter and e-bike services.

- Johns Hopkins School Bloomberg School of Public Health has relaunched their targeted equity zone survey, a
 scientific survey sent to riders who start or finish trips in the designated equity zones where vehicles are
 deployed daily.
- BCDOT and MDOT MTA are piloting signs to solicit feedback on vehicles near rail stations, collecting both requests and reports for any issues related to the vehicles. To date, 15 survey submissions have been received: 13 (87%) were requests for additional vehicles at specific rail stations and 4 (27%) reported issues related to the vehicles.

Policy Updates: Due to increasing foot traffic and cobblestone streets, the waterfront slow zone for e-scooters has been expanded to cover more of the Fell's Point area around Broadway Square. This addition was requested by the Baltimore Police Department as more people are returning to public events and spaces.
