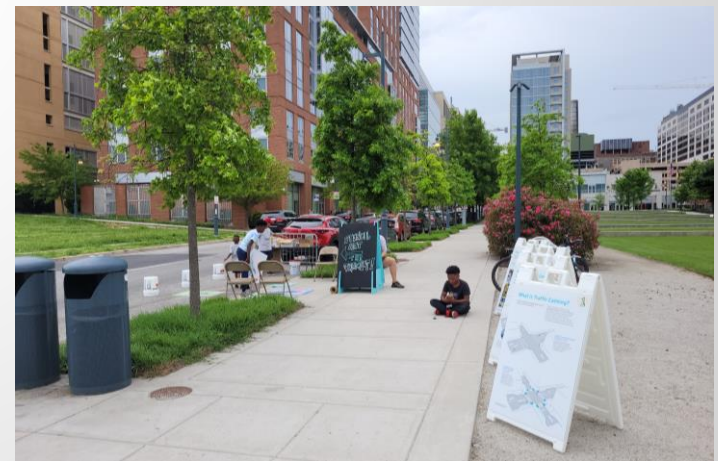

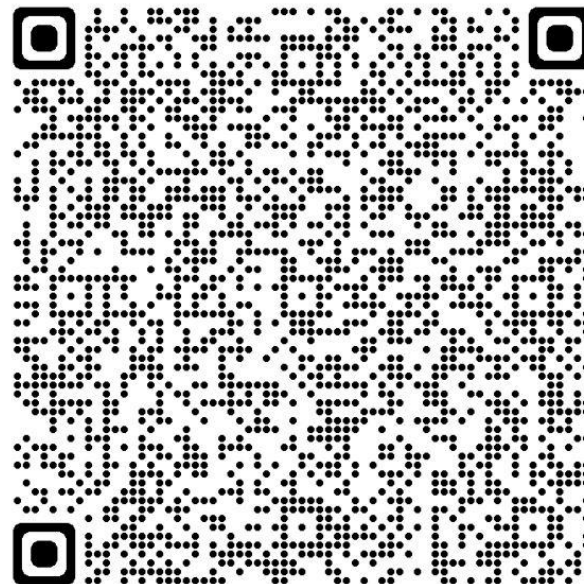
2022 Public Bike Program Schedule

- **Saturdays May-Oct (9am-3pm)**—Lake Montebello and Herring Run rides

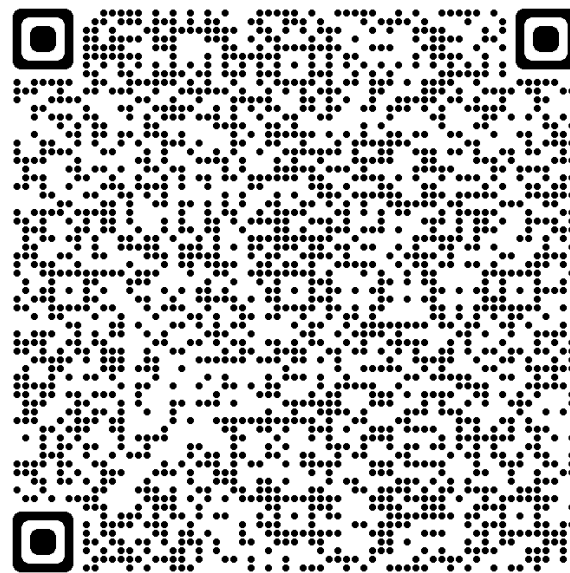
2022 Rec Center & School Bike Program Schedule

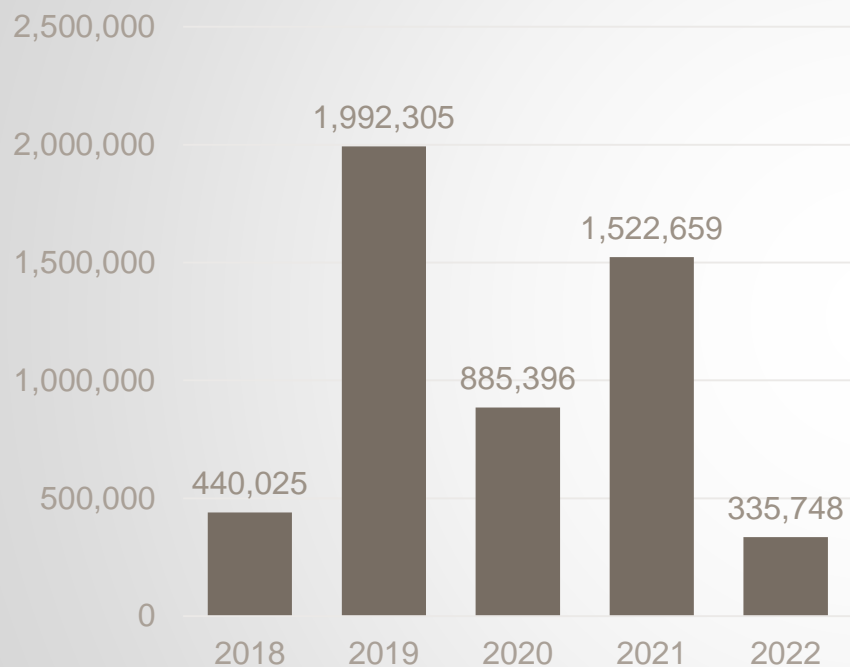

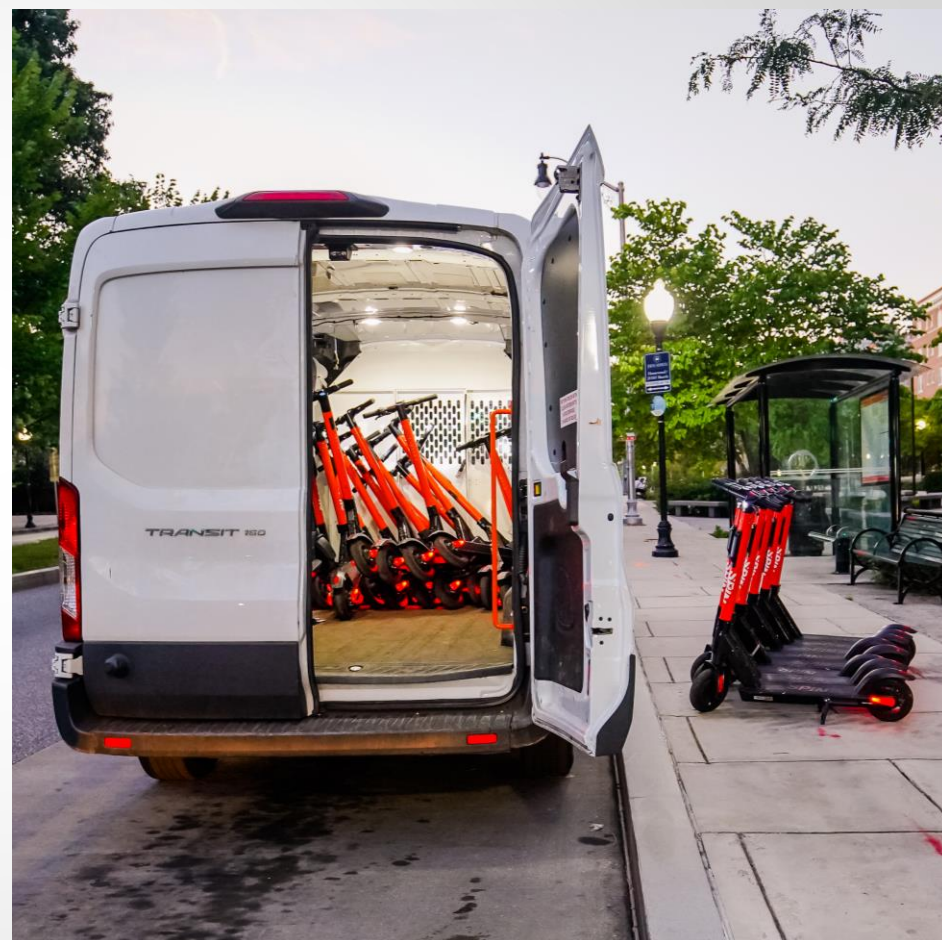

October 2018- April 2022

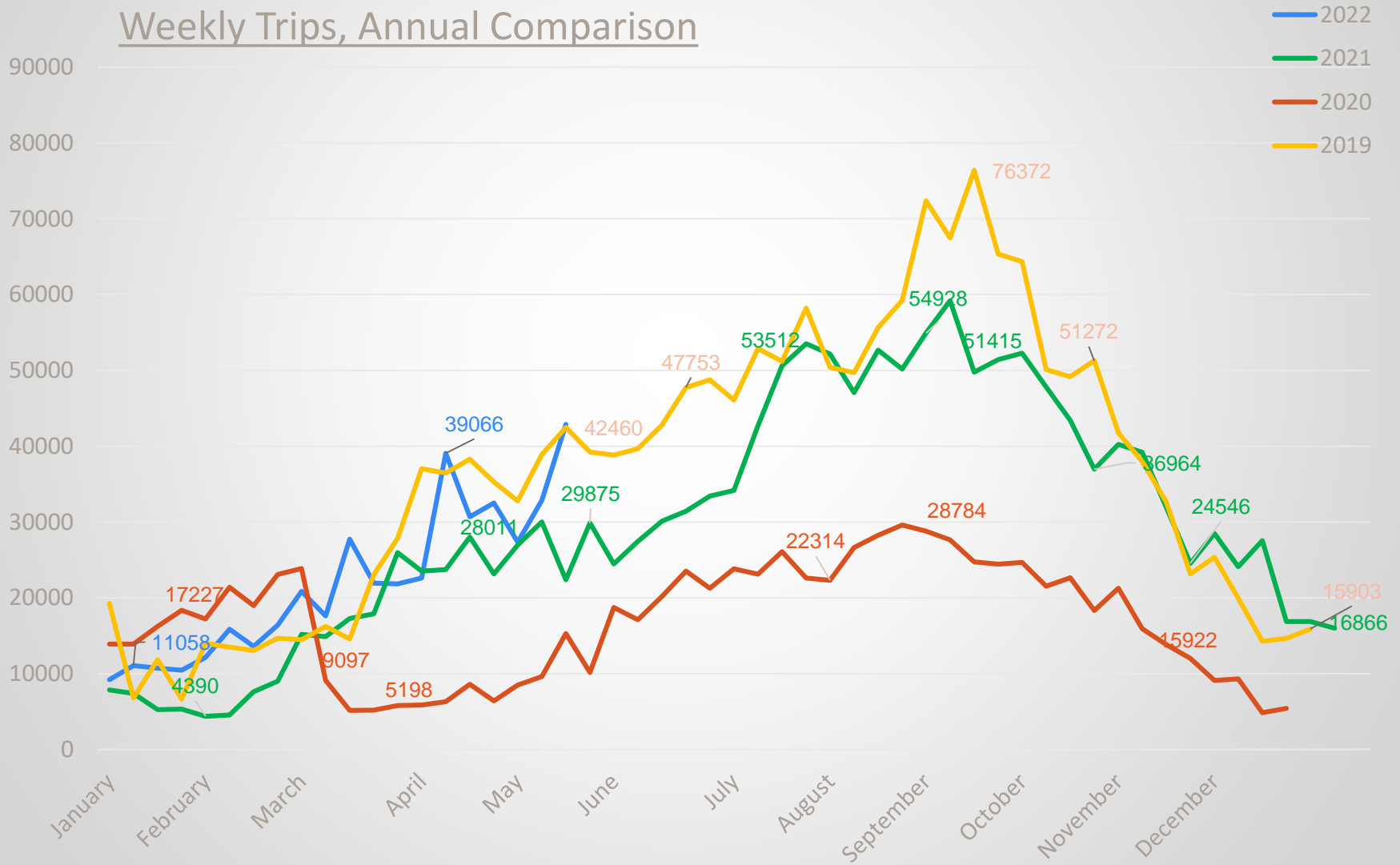
- Total Trips: 5,176,133

Renewal Metrics

For the first time, Dockless Vehicle Permit Holders were scored for renewals. Spin received the highest score and was awarded a 1-year renewal. Permit holders Spin, Link, and Lime were scored in the following categories for renewals:

2022 Permits

- Renewal announced April 29, 2022: Spin
- Application open May 2-20, 2022: 4 applications for 2 permits
- Permits to be awarded June 6 and active July 1, 2022

DVC

- July 13 – Intro to new permit holders
- October 12 – Programming updates and RFP Discussion
- January 11 – Survey and Annual Revisions

Future Permits

- 2023: Anticipating 2 permits and a possible RFP for supporting services (adaptive vehicles, e-bikes, equitable outreach)

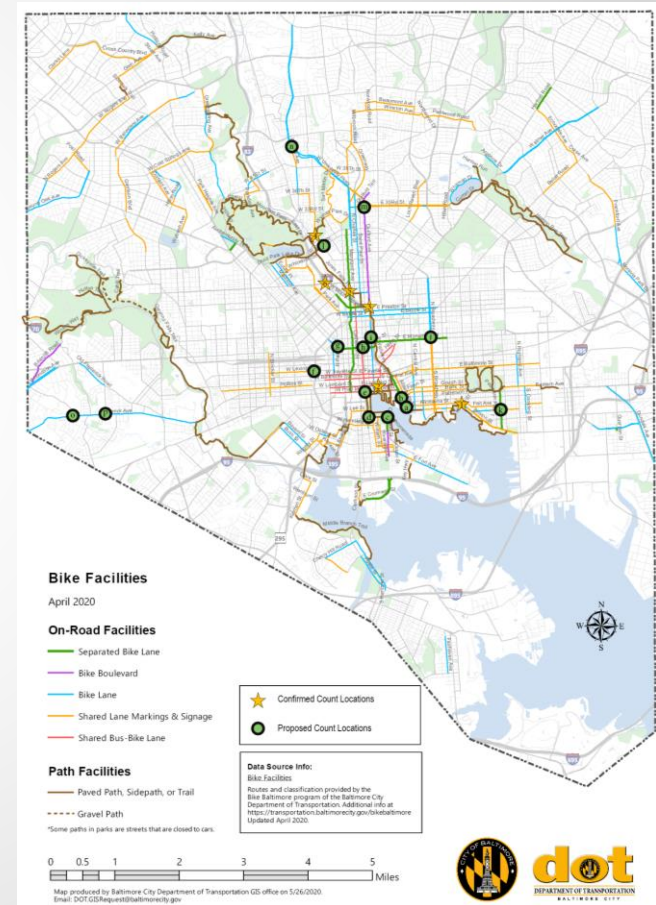

Automatic Bike Counter Public Outreach Strategy Updated

- **Revised Survey nearly complete**
 - Will be emailed to members of bike groups
- **Focus Group – Request 10 volunteers**
 - Selected from MBAC members
 - Collect feedback about types of counters and installation locations prior to purchase

Metro Count Temporary Automatic Bike Counter Pilot
