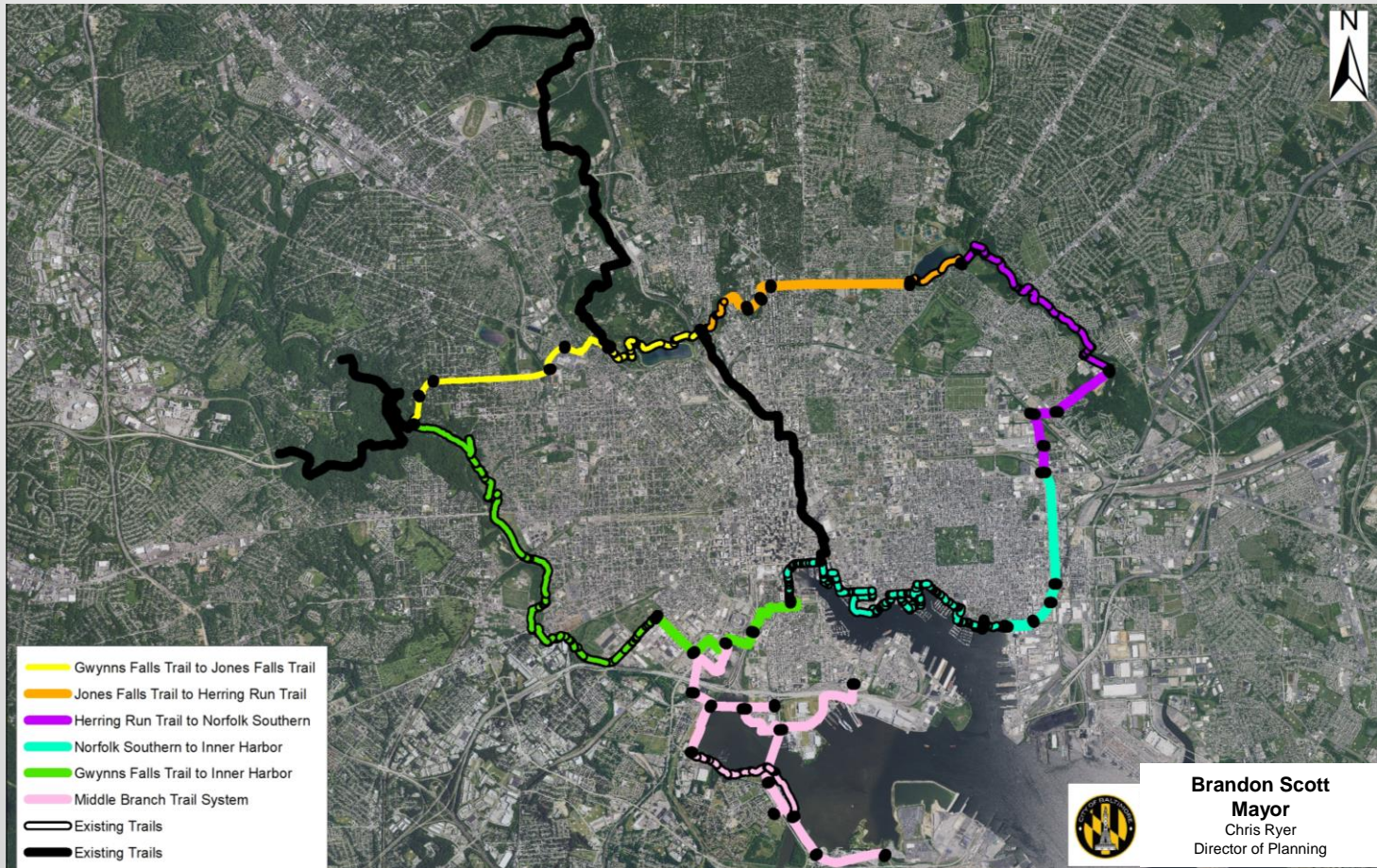

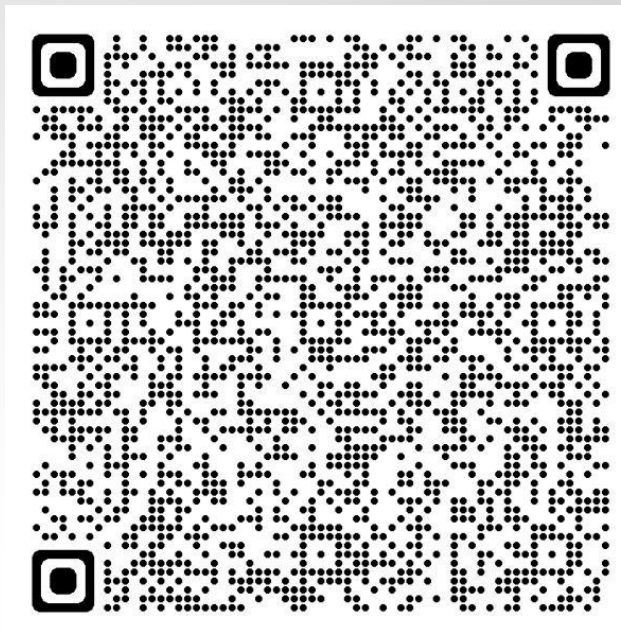
2022 Public Bike Program Schedule

- **Saturdays May-Oct (9am-3pm)**—Lake Montebello and Herring Run rides

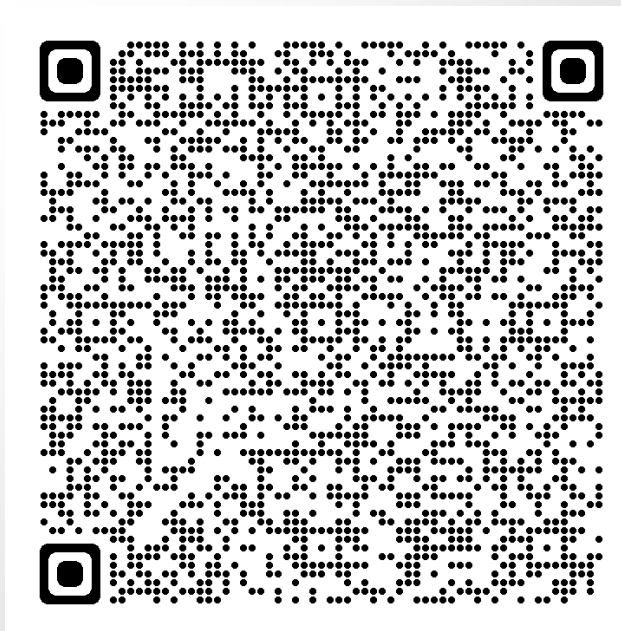
2022 Kids on Trails program

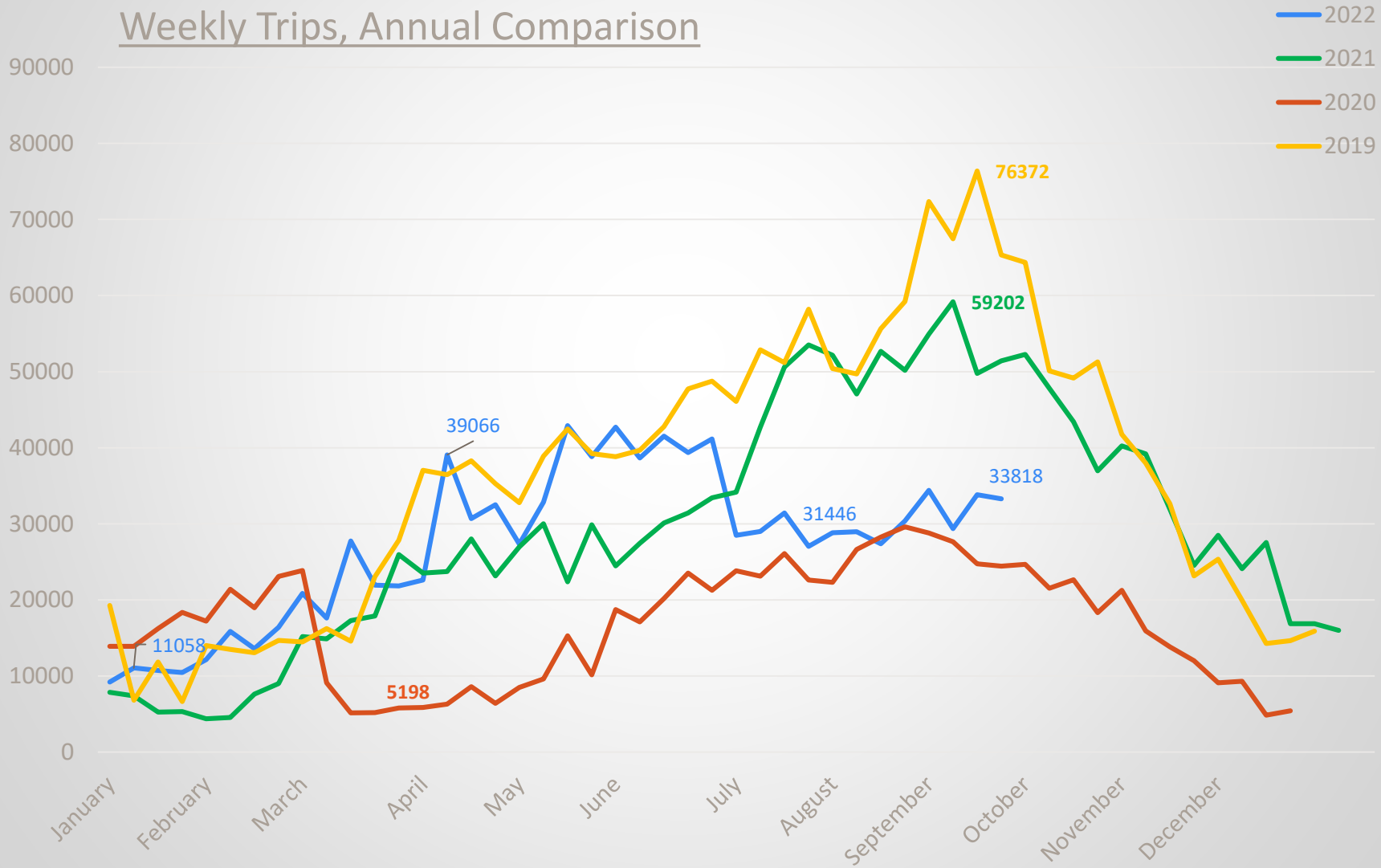
- Pump track is setup at Carroll Park until October.

There was a 72% increase in rides in 2021 compared to 2020

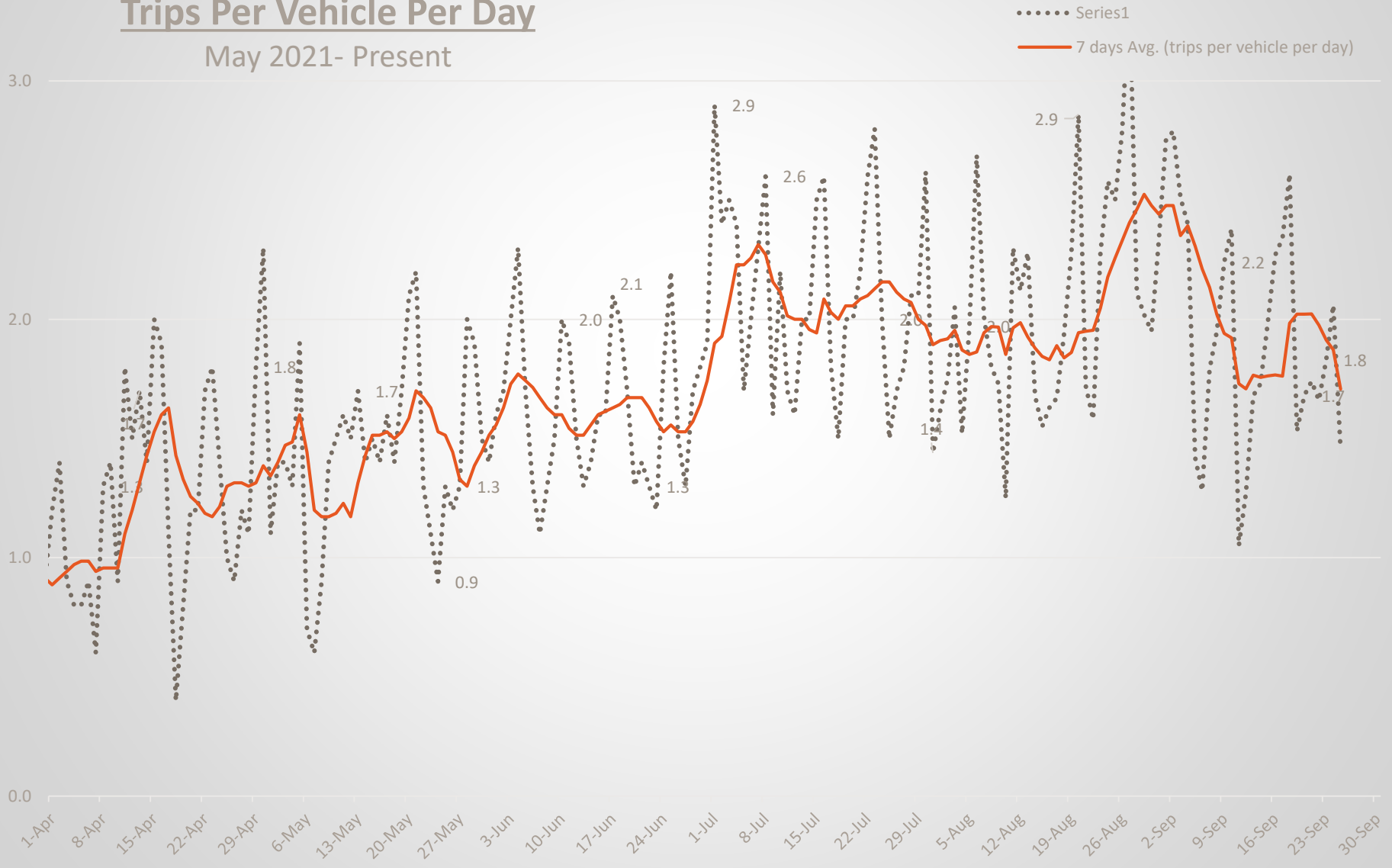
Weekly Trips, Annual Comparison

North Avenue Trip Counts: A First Look at the Impact of North Avenue Rising

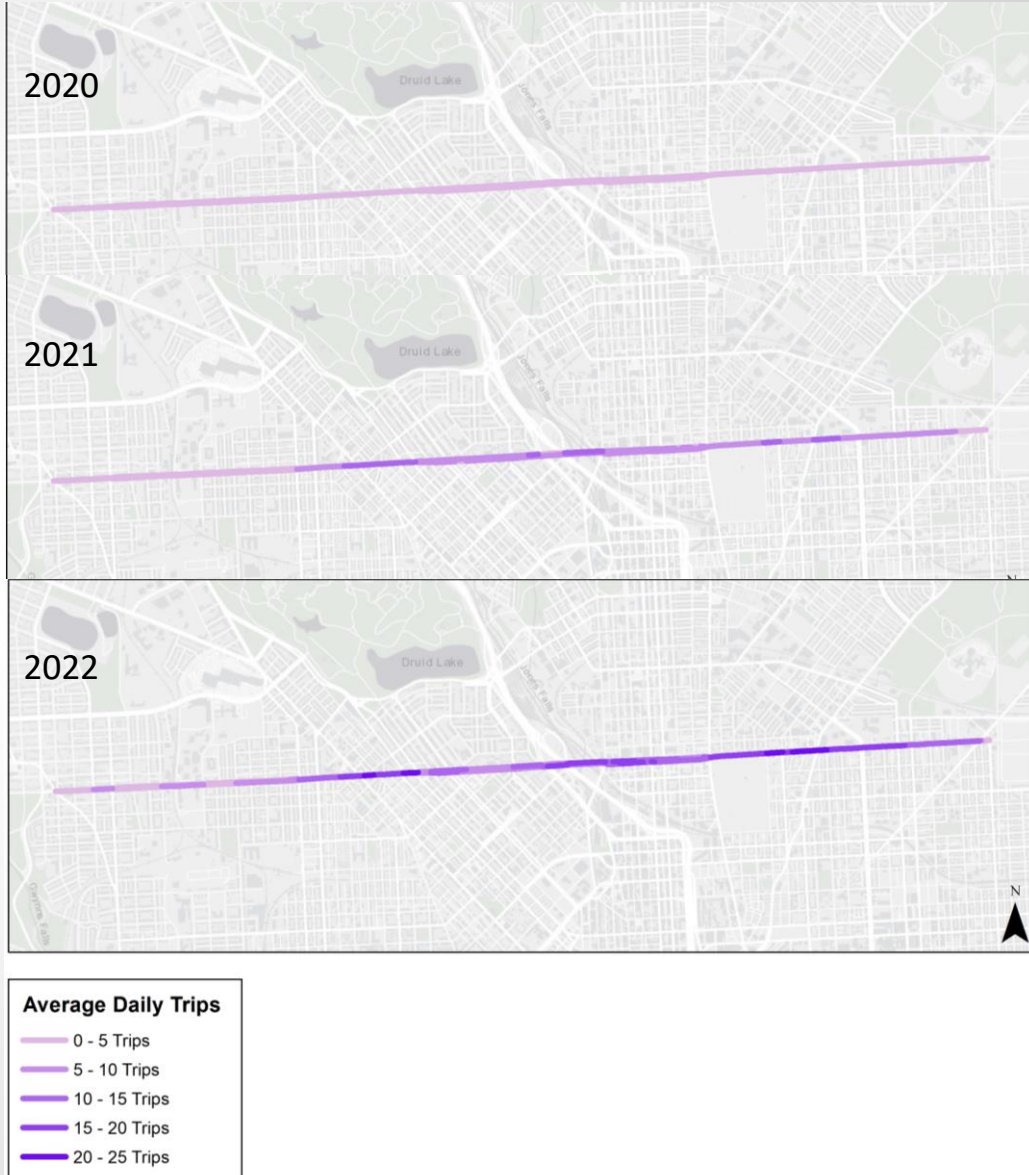
Facilities installed:

- shared bus/bike lanes
- short cycle track over the I-83 bridge
- bicycle and scooter parking corrals along the corridor.

Looking at ridership over the past 3 years, there has been a significant increase in e-scooter and e-bike ridership in the corridor. On the key section of the bridge over I-83 daily trips increase:

- 7 in 2020
- 18 in 2021
- 30 in 2022

Note: these counts only capture about 92% of dockless trips due to technical issues with GPS. Counts are believed to be about 40% of total scooter and bike ridership because trips on personal vehicles are not included and do not report GPS trip data.

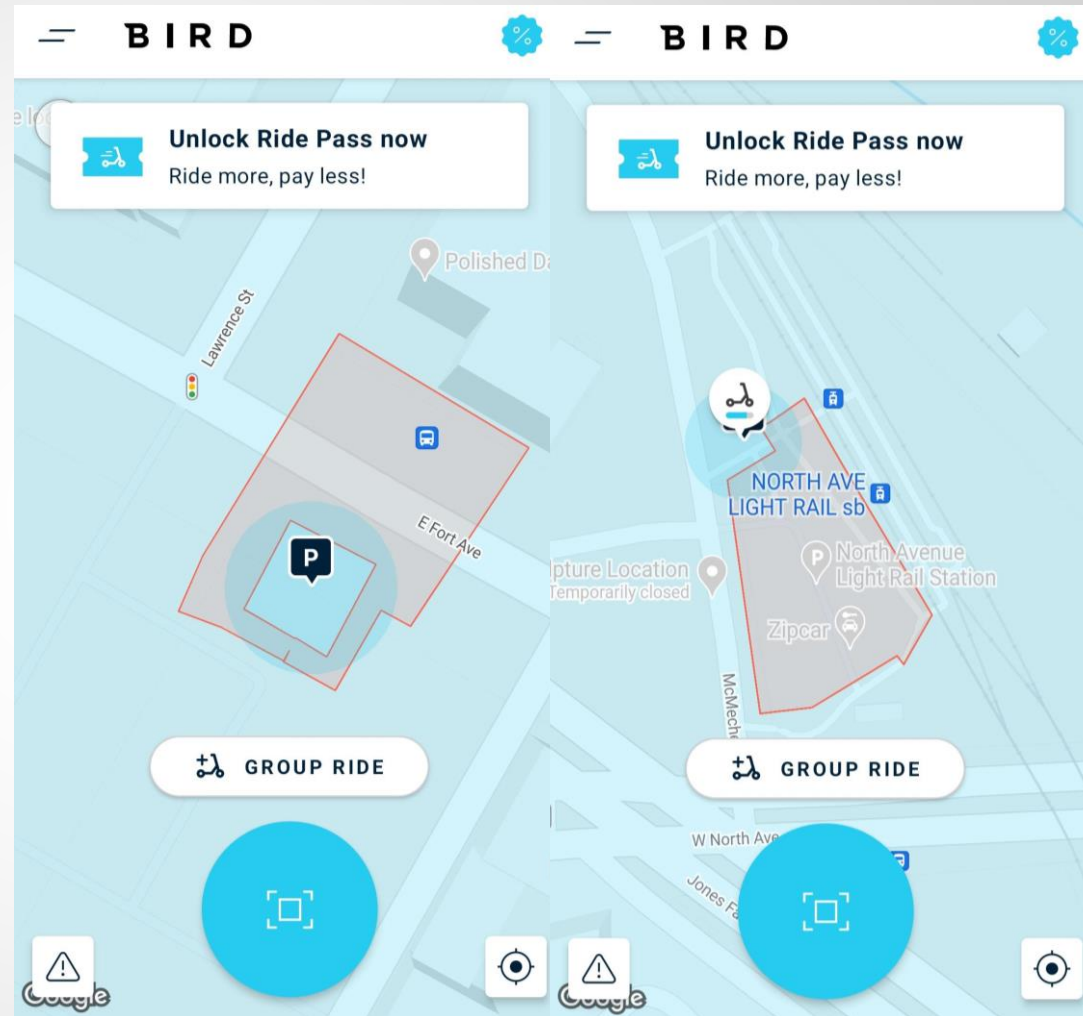


New Round of Corrals

- Installing corrals and taking requests – 125 total by end of this phase
- Percentage of vehicles parked on blocks with corrals will increase from approximately 18% to 25%.
- Piloting no-parking zones around corrals in select locations
- Focus on universities

In development - RFP for FY 24

- Services sought: Leading a coalition and handling funds for a group of organizations supportive of all things for small wheels
- Goals: Reducing vehicle vandalism and changing perceptions of who rides vehicles
- Tactics: sponsoring programming at community events, creating a network of ambassadors across non-profits, and foster work force development

- Eutaw Place: Druid Park Lake Drive to Druid Hill Ave/Centre
 - Scheduled Spring/Summer 2023
- Harford Road Bridge near completion
- Vision Zero into construction queue
