

- Ellen Worthing: Us data people really like Open Baltimore. It's where we look for data. Please put it on Open Baltimore. Looks like companies are allergic to Curtis Bay and Brooklyn.
 - DOT will look into coordinating with Open Baltimore. DOT will confirm the companies are in compliance with deployment regulations in these areas.
- Jed Weeks: Any updates on coordination with 311?
 - The Dockless Vehicle Program provides 311 with the companies' contacts and vehicle information in case a resident contacts 311 to have a scooter moved. DOT does not encourage residents to contact 311 to have Spin or Superpedestrian's vehicles moved. The fastest way to have the vehicles moved is to contact the companies directly.
