

# REQUEST FOR AUTOMATED ENFORCEMENT CAMERAS IN BALTIMORE CITY

## (Speed, Red Light, Commercial)



The Automated Traffic Violation Enforcement System (ATVES) began implementing Speed, Red light, and Commercial (truck) enforcement cameras in 2017, aiming to increase safety on city streets by reducing crashes and improving driver behavior. **Safety is our #1 Priority!**

Camera placement is largely data driven, targeting some of the city's most dangerous locations. ATVES also recognizes that it is important for communities to identify problematic locations. The ATVES encourages recommendations from the general public regarding ideal placement of automated enforcement cameras.



### Process for requesting a Speed, Red Light, or Commercial (Truck) Enforcement Camera near you:

**Step 1:** Submit the completed request form (below) to [ATVES.Project@baltimorecity.gov](mailto:ATVES.Project@baltimorecity.gov) or address below.

**Step 2:** Once the request is received, DOT will conduct a site evaluation, which consists of field visits with findings documented, and data collection and analysis.

**Step 3:** If the location is determined to warrant enforcement, ATVES will present the location to the "Location Evaluation Committee", which consists of representatives from the Department of Transportation and the Baltimore City Police Department. The committee meets once per month.

**Step 4:** If approved by the Location Evaluation Committee, then the DOT Director must sign off for final approval.

*A proposed camera location must be approved by both the committee and DOT Director prior to implementation. Please allow up to 60 days for this process.*
