The Director of the Department of Transportation reserves the right to terminate this Right of Entry if said Director deems it in the best interests of the City to do so.

The person executing this Right of Entry on behalf of GRANTEE represents and warrants that this Right of Entry has been authorized by all necessary parties, is validly executed by an authorized officer or agent of GRANTEE and is binding upon and enforceable against GRANTEE in accordance with its terms.
